Section 3. Composition and information on ingredients

This product contains the following components and mixture of the following substances with non-hazardous additions.

Proteinase K:

Contains < 5 % Proteinase K (CAS #: 39450-01-6), 40-50 % Glycerol (CAS#: 56-81-5)

Magnetic Beads A:

The buffer contains no substances which at their given concentration, are considered to be hazardous.

Lysis Buffer A:

Contains 20-50% Guanidine Thiocyanate (CAS #: 593-84-0)

Binding Buffer 5:

The buffer contains no substances which at their given concentration, are considered to be hazardous.

Contains 20-50% Guanidine Thiocyanate (CAS #: 593-84-0)

Section 4. First aid measures

Section 5. Fire Fighting measures

Extinguishing media: carbon dioxide (CO₂), extinguishing powder or water spray or alcohol-resistant foam.

Protective equipment and precautions for firefighters: Standard procedure for chemical fires.

Section 6. Accidental release measures

Actions to be taken on spillage:

Wash off small quantities with plenty of water. Small spills: Take up with sand or other noncombustible absorbent material and place into containers for later disposal. Large spills: Dike far ahead of liquid spill for later disposal.

Absorbent material:

Contain and collect spillage with non-combustible absorbent material (e.g., sand, earth, diatomaceous earth, vermiculite), and place in container for disposal according to local / national regulations

Actions to be taken to limit damage:

Prevent release to the environment if possible. Prevent discharge of the product into the sewage system, cesspits and cellars. Vapors produce potentially explosive atmosphere If substance has entered a water course or sewer or contaminated soil, advise police or fire brigade.

Section 7. Handling and storage
